Commissioner Report February 6, 2018

Main St. Pedestrian Sidewalk Enhancement

The CDA submitted additional documents requested by NYSDOT for the approval of Roadwork Ahead Inc. as the contractor for the construction portion of the grant. We recently received another request from information from NYSDOT, the CDA is reviewing the request and will provide NYSDOT with the information by the end of this week.

Safe Routes to School

The CDA has received approval from NYSDOT to advertise the Bid to contractors. We are working with NV5 and the Village of Hempstead Purchasing Department to follow federal guidelines for the bidding process. The bid should be advertised in February.

NV5 has submitted the final design review packets for the AGBS Middle School and Jackson Main Elementary School. We are now awaiting NYSDOT response to the packets.

Brownfield's Opportunity Area

The CDA met with AKRF to review the findings from the steering committee meeting and evaluate the next steps. AKRF will follow up on the concerns from the meeting and continue working on the study.

Local Initiative Support Coalition

The CDA will be working with department heads at the Village of Hempstead to implement MuniCity software on their computers. We will also be holding seminars in April, May, and June for all Village residents on Financial Planning and Foreclosure prevention.

Community Development Block Grant

The CDA is preparing for the 44th Year CDBG application process. There is a public hearing held by Nassau County on February 15, 2018. We are also waiting on the full approval of our 43rd Year CDBG contract.

CDA Properties

The CDA would like to use CDA properties to encourage home ownership by creating opportunities for first time home buyers. We are looking at partnering with other organizations to make home buying affordable for Village Residents.

Poverty Initiative

The Phase 1 report created by United Way has been accepted. United way will now create and advertise request for proposals to follow the recommendations for the community and steering committee. The CDA will work with United Way and its personally to oversee the request for proposals and the selection process.
